The income statistics above are for Active Numis Network Independent Collector Representatives (“ICRs”). An “Active ICR” is defined as any person who has (1) executed a Numis Network ICR Application; (2) purchased a Numis Network Associate Representative Starter Kit or the Executive Success System ; (3) personally generated at least 60 points in Qualified Volume over the previous 35 days; and (4) has not been cancelled or terminated for any reason. The average annualized income for all ICRs (both active and inactive) during the period was \$ 222 USD. From July 1, 2009 to June 30, 2010, approximately 72.6% of individuals who executed a Numis Network ICR Application did not earn a commission or bonus under the compensation plan.

*ICRs at the Rank of Five Star are eligible for the Five Star Bonus Pool, which is paid monthly. The Five Star income represented in this section includes both the Weekly Earnings and monthly Five Star Bonus Pool earnings. The Five Star rank has only been active since January of 2010. All 5 Star income figures represent only six months of activity.
