

# U.S. INCOME DISCLOSURE STATEMENT

PERIOD BEGINNING FEBRUARY 1, 2011 THROUGH SEPTEMBER 30, 2011

The following Income Disclosure Statement presents the actual earnings data of Numis Network Independent Collector Representatives (“ICRs”) in the United States and Canada. All monetary amounts are designated in USD and include retail commissions.

The income statistics above are for Active Numis Network Independent Collector Representatives (“ICRs”). An “Active ICR” is defined as any person who has (1) executed a Numis Network ICR Application; (2) purchased the Numis Network Success System ; (3) personally generated at least 60 points in Qualified Volume over the previous 35 days; and (4) has not been cancelled or terminated for any reason. The average annualized income for all ICRs (both active and inactive) during the period was \$ 306.95 USD. From February 1, 2011 to September 30, 2011, approximately 83.5% of individuals who executed a Numis Network ICR Application participated as coin collectors only. The numbers above reflect the results of the enhanced Numis Network compensation program that went in to effect on January 10<sup>th</sup>, 2011.
