During the reporting period, the average income of those associates was \$737.74. The "Average Days to Achieve Position" represents any Stream Qualified Director or a qualified Managing, Senior, or Executive Director who held the corresponding position at any time during 2014 and the average time it took members in that position to achieve it from the time they initially enrolled with Stream.
