The income statistics above are for all active U.S. MyDailyChoice Affiliates who were eligible to earn downline commissions during the time period. An "active distributor" is defined as an Affiliate with a minimum of 40 Business Volume either generated from Personal Orders or Retail Customers. Affiliates who were inactive during the time period received no income. Affiliates at the Unranked/Inactive status are not included in the statistics above because Unranked/Inactive Affiliates are not eligible to earn downline commissions. The average annual income for all Affiliates (active and inactive) during the reporting period was 580.08 USD, and the median annual income for all Affiliates in the reporting period was \$0 USD. 70.3% of all Affiliates do not continue with MyDailyChoice after their first year. Out of approximately 37,124 Affiliates that signed up as U.S. Affiliates during the time period, approximately 26,123 were still active at the end of the year.

During the time period, 24,941 of all Affiliates received no income at all.
