On February 3, 2025, Detective Marek Molcan #284 was assigned a follow-up regarding a battery that occurred at 2800 N. Horseshoe Dr. Naples, FL on January 31, 2025. Mollie Bridget Messuri (DOB: February 20, 1990), stated that her neighbor, Patrice Marie Mobley (DOB: September 7, 1954) and Isabel Dorinda Cerrato (DOB: June 16, 2005) pushed her while at the above address.

In Messuri's original written sworn statement, she stated the following:

Messuri entered 2800 Horseshoe Dr at approximately 1345 hours. While Messuri was standing in line waiting at the guest services, she heard someone say, "There's that fucking bitch". When Messuri turned her head to the right, she observed Mobley and Cerrato. Mobley and Cerrato approached Messuri and pushed her, grabbed and shoved her. Messuri stated that Mobley continued to scream as Mobley was touching her body. Messuri stated that Mobley said that she's, Messuri, is a bitch and that she better move the trailer out of the driveway, and she better move it fast, if she knows what's good for her. Messuri stated that Cerrato was laughing, and she could not make out what she was saying over Mobley.

Messuri stated that she wished to press charges.

The witness, Thomas Patrick Rusin (DOB: January 12, 1967), completed a written sworn statement stating the following: Rusin stated he was standing by the counter by the exit when he observed two ladies walking out, while another woman, Messuri, just entered in the front door. The ladies walking out, referring to Mobley and Cerrato, yelled "You fucking bitch" and Messuri yelled "I am going to sue you", while waving her arms around not moving from where she stood. Mobley and Cerrato tried to leave and pushed past the "little room". They, Mobley and Cerrato, may have touched the victim but Rusin stated that he could not say with confidence if they did. Rusin stated that the lady at the front doorway, referring to the Messuri, left very little room for the ladies, Mobley and Cerrato, to fit through. Rusin was worried that a flight could occur, so he notified security.

Detective Molcan attempted to contact the witness, Rusin, via phone but was unsuccessful; unable to leave a voicemail.

Detective Molcan attempted to contact Messuri but was unsuccessful; a voicemail was left requesting a callback.

Detective Molcan responded to 2800 N. Horseshoe Dr and met with Rusin. Rusin stated that he did recall the incident but stated that he did not see if either party touched each other. Rusin stated that he did not have access to the cameras but stated that the security officer might. Detective Molcan met with the security officer, and he stated that he did not have access to review the camera footage and could only monitor the live footage.

Detective Molcan responded to Mobley's home to meet with her, but she was not at her residence. Detective Molcan was able to meet

Mobley's granddaughter, Cerrato, who was with Mobley at the scene of the incident.

Cerrato stated that on January 31st, 2025, she went to the Collier County Building Department, 2800 N. Horseshoe Dr. When Mobley and Cerrato were going to exit the building, she saw Messuri inside the building and informed Mobley. Cerrato stated that Mobley began to yell at Messuri, but Cerrato told her to stop, which she did. While Mobley and Cerrato were exiting the building, Messuri did not move from the doorway causing Mobley to brush against Messuri. Messuri yelled that Mobley punched her and Cerrato told her that no one touched her. Cerrato stated that Mobley did not intentionally brush her, she was just trying to exit the building.

Cerrato completed a sworn statement documenting the incident.

Messuri returned Detective Molcan's call and stated the following regarding the incident:

While in line at 2800 N. Horseshoe Dr., Messuri observed Mobley come out of nowhere and Mobley began screaming, "you fucking bitch", "you better fucking move", "Ima light your house on fire", and "Ima light that trailer on fire". Then, Mobley and her granddaughter, referring to Cerrato, came towards Messuri and tried to rip documents out of her hand, they grabbed the bottom of her hair, they grabbed her bag, they dug their finger nailed into her, they pushed her, and pushed the person behind her. Messuri stated that both Mobley and Cerrato put their hands on her.

Messuri also mentioned other incidents that did not occur within the City of Naples, and she was informed to file a report with the Collier County Sheriff's Office.

Detective Molcan was able to obtain footage from the lobby of 2800 N. Horseshoe Dr that recorded the incident and observed the following: At approximately 1357 hours, Messuri was observed standing in line directly by the front entrance/exit as Mobley and Cerrato were walking towards the exit. Messuri then stepped closer to the exit, blocking the doorway. Mobley walked past Messuri, on her right-side, possibly brushing against her, no intent to make contact or cause harm was observed. Cerrato walked past Messuri but did not make any contact with Messuri. It shall be noted, Mobley and Cerrato did not touch any documents that were in Messuri's hand, did not pull her hair, and did not dig their nails into her body.

On February 5, 2025, Mobley met with Detective Molcan at the Naples Police Department regarding the incident that occurred on January 31, 2025. Mobley stated that she was at the permitting department on Horseshoe Dr. Mobley stated that Messuri was in line, along with other serval people, and that's when she said something to her due to the issues she caused since moving into their neighborhood. Mobley stated she just wanted to leave and while exiting she pushed up against Messuri unintentionally. At this time, Messuri began saying that Mobley pushed her and that she was going to sue Mobley. Mobley stated that she did not punch or push Messuri, as Messuri claimed. Mobley stated Cerrato was present and observed what occurred.

Mobley completed a sworn statement documenting the incident.

On February 10, 2025, Messuri met with Detective Molcan at the Naples Police Department in a recorded interview room. It shall be noted that Messuri had her lawyer, James R. Chillemi, present. Before Detective Molcan spoke to Messuri, she was sworn to tell the truth. Messuri stated she was at 2800 N. Horseshoe Dr regarding Animal Control paperwork. While in line she heard someone yelling "That fucking bitch is here, that fucking bitch". Messuri stated that Mobley and Cerrato came flying over and Mobley said, "You fucking moron" and got in her face, stating that she approached her. Messuri stated that she moved out of the way, and she kept coming towards her. Messuri stated they, referring to Mobley and Cerrato, just tried to grab her and grab everything. Per Messuri, Mobley and Cerrato stated that she "Better fucking move, you better move that trailer", and then everyone started screaming. Messuri stated that Mobley and Cerrato fled from the scene.

Detective Molcan stated that while on the phone with Detective Molcan, Messuri stated that they shoved her, and he asked her how she was pushed. Messuri stated that both Mobley and Cerrato pushed her with one hand and that they pulled anything they could, stating it was a "Mad Grab". Messuri stated that she said to stop touching her and she tried to move but Mobley and Cerrato grabbed onto her crossbody bag. Messuri stated that the person behind her opened the door, and Mobley and Cerrato fled out. Messuri stated that this interaction was under a minute long.

Messuri was shown the footage that Detective Molcan obtained from Collier County Facilities, and she confirmed she was the subject in the video. Messuri also identified which direction Mobley and Cerrato came from and who they were in the footage.

Detective Molcan does believe that there is probable cause for the arrest of Mollie Bridget Messuri for the offense of – False Reports to Law

Enforcement Authorities, which is a violation of Florida State Statute 837.05(1)(a). Messuri completed a sworn statement in the presence of Officer Jake Crowther and provided false information to him while reporting claims of battery. Also, Messuri verbally communicated false statements, reasserting being a victim of battery to Detective Molcan via recorded phoneline during a follow-up interview. Additionally, during an in-person interview at the Naples Police Department on February 10, 2025, Messuri provided a video recorded sworn statement that included false information.

Messuri was placed under arrest and transported to the Naples Jail Center by Officer Tyler Lapierre #345 without any further issues.
