Court ordered a DNA sample and advised defendant of applicable surcharge. SENTENCING HEARING HELD: Statements by the State, Defense counsel and Defendant. COURT ORDERED Defendant to serve 120 DAYS the House of Correction with credit for 1 DAY time served with Huber privileges for Work and treatment. Good Time Credit to apply. Court ordered defendant REMANDED into the custody of the Milwaukee County Sheriff's Department. * Pay Fine in the amount of \$600.00 Plus Costs, fees and surcharges due in 1 Year or Civil Judgment. * Provide a DNA Sample and pay the related surcharge. * Defendant to install the ignition interlock device on any vehicle owned, operated and titled in her name for 26 Months. * Defendant operating privileges revoked for 26 Months. * Court ordered AODA assessment and Driver Safety Plan * APPELLATE RIGHTS GIVEN AS TO COUNT 2 Pursuant to negotiations and on the Motion of the State, Court Ordered Charge DISMISSED as a matter of law.
