- Partners – Individuals who have chosen to pursue the Xyngular business opportunity to sell Xyngular products. Xyngular Partners can purchase products at wholesale price with the potential to earn commissions and rewards by selling products to others. The sign up cost and annual fee to be a Partner in the U.S. is \$49.95 USD.

Compensation

There are two ways in which a Partner can earn compensation:

1. Retail markup on products sold to their individual customers.
2. Sales commissions and bonuses paid by the company based on the Partner's product sales and sales of Partners on their team. There is no income earned or bonuses paid from sponsoring or recruiting others into the Xyngular business.

Xyngular provides Partners with an opportunity to earn income by selling products and services they are passionate about, while enjoying flexibility, mentoring and social interaction. Neither Xyngular nor its Partners guarantee any level of income. Each Partner's success in earning income will depend on his or her efforts, abilities, networks, and circumstances.

Average Earnings

In 2022 there were Partners that did not sponsor another Partner or customer and, therefore, remained single-level Partners who did not earn commissions. Only Partners who have organizations that sell products to customers are eligible to earn commission payments from the company, although all Partners may earn income by selling products at a retail mark-up to their customers.

Xyngular Independent Partners are individuals who have decided to sponsor other individuals into the Xyngular business as a Partner or customer. By doing so they have chosen to participate in the Xyngular Compensation Plan. It is important to note that Xyngular Partners are not paid anything for sponsoring new Partners or customers. Commissions are earned from the sale of products to customers and Partners.

For those individuals who have sponsored another person into their downline organization, the average gross income is \$1,170, the median income per year is \$188. This figure does not account for retail profit earned by the Partner or expenses. Expenses may reduce your net income and can include registration/renewals fees, product purchases, events, taxes, travel, optional training, marketing support materials, etc.

The table below summarizes the average commissions paid to all active Partners in 2022, regardless of whether the Partner has sponsored another Partner. This is a summary of the 41.96% of Partners who earned income. 58.04% did not earn income in 2022.
